On average, over 93 percent of the votes were cast for the 10 persons nominated by the Board to serve as directors: Susan K. Avery, Angela F. Braly, Ursula M. Burns, Kenneth C. Frazier, Steven A. Kandarian, Douglas R. Oberhelman, Samuel J. Palmisano, Steven S Reinemund, William C. Weldon, and Darren W. Woods.

The Ratification of Independent Auditors, Advisory Vote to Approve Executive Compensation, and the seven shareholder proposals received votes as detailed in the table below.
